LPPS is looking forward to another great year of teaching and learning in 2026. As part of our preparations, we would like to provide you with information regarding the school's voluntary financial contributions for the year ahead.

In line with the Department of Education's policy, schools provide free instruction to deliver the standard Victorian Curriculum. We want to take this opportunity to reassure all families that financial contributions are strictly voluntary. Extra-curricular items and activities are provided on a user-pays basis.

While contributions are not compulsory, the ongoing generosity of our community has played a vital role in enhancing the educational experiences we are able to provide. The support of families has enabled LPPS to extend well beyond the delivery of the standard curriculum. These contributions strengthen our academic programs, broaden the range of engaging opportunities available, and ensure that every student can access the resources and supports they need to thrive.

Over the years, the impact of this support has been clearly reflected in our school's growth and achievements. From additional learning programs and wellbeing initiatives to improved digital technologies, library collections, and extracurricular opportunities, family contributions have made a meaningful difference. They have enabled us to create a learning environment that nurtures excellence, innovation, and care for every student.

In addition to explicit lessons in Literacy, Numeracy, and Inquiry, students benefit from a broad and dynamic Specialist Program alongside a wide range of enriching experiences. These include THRIVE sessions, Swimming, Physical Education and Sport, Music, Performing Arts, Visual Arts, STEM, and Auslan. Contributions also support targeted intervention programs, ensuring that students who require extension or additional support are provided with opportunities to achieve their full potential.

We are also very fortunate to have recently redeveloped our playground spaces, ensuring all students have access to safe, engaging, and age-appropriate play areas. Complementing these are our well-maintained facilities, including a synthetic oval, basketball and hockey courts, and an indoor swimming pool.

ONE PAGE OVERVIEW



FREE INSTRUCTION

- Schools provide students with free instruction and ensure students have free access to all items, activities and services that are used by the school to fulfil the requirements of the Curriculum. This includes the Victorian Curriculum F-10, the Victorian Certificate of Education (VCE) including the VCE Vocational Major and the Victorian Pathways Certificate.
- Schools may invite parents to make a financial contribution to support the school.



PARENT PAYMENT REQUESTS

Schools can request contributions from parents under three categories:

Curriculum Contributions

Voluntary financial contributions for curriculum items and activities which the school deems necessary for students to learn the Curriculum.

Other Contributions

Voluntary financial contributions for non-curriculum items and activities that relate to the school's functions and objectives.

Extra-Curricular Items and Activities

Items and activities that enhance or broaden the schooling experience of students and are above and beyond what the school provides for free to deliver the Curriculum. These are provided on a user-pays basis.

- Schools may also invite parents to supply or purchase educational items to use and own (e.g. textbooks, stationery, digital devices).



FINANCIAL HELP FOR FAMILIES

- Schools put in place financial hardship arrangements to support families who cannot pay for items or activities so that their child doesn't miss out.
- Schools have a nominated parent payment contact person(s) that parents can have a confidential discussion with regarding financial hardship arrangements.



SCHOOL PROCESSES

- Schools must obtain school council approval for their parent payment arrangements and publish all requests and communications for each year level on their school website for transparency.
